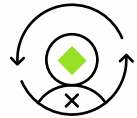

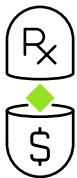


Retroactive Terminations

Recovers claims paid after member termination, often by rebilling to new coverage. Features include continuous mining of terminated policies & eligibility validation, member outreach + flexible payment options, and an online repayment portal.

Pharmacy Coordination of Benefits (COB)

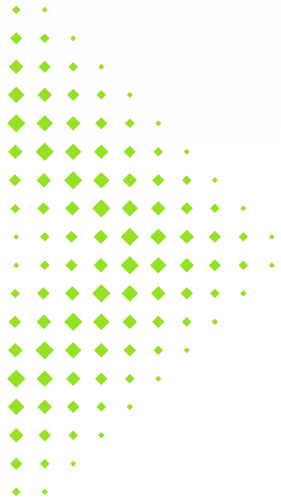


High Cost/ Specialty Drug Management

Medicare Part D Compliance

Background: A national payer engaged us due to a Corrective Action Plan (CAP) for MSP Group Health Plan and Skilled Nursing Facility claims. The plan had already deleted more than \$10 million in Prescription Drug Events (PDEs) and had identified another \$100 million that appeared to conflict with the Long Term Institutionalized Resident Report.

Our approach:

- Identified \$80 million of valid PDEs (sponsor mining logic was over inclusive)
- Restored \$10 million of deleted PDEs and validated to delete only mistaken payments and preserve subsidies of valid payments
- Completed back sweep review in six months to satisfy CAP

Key results:
